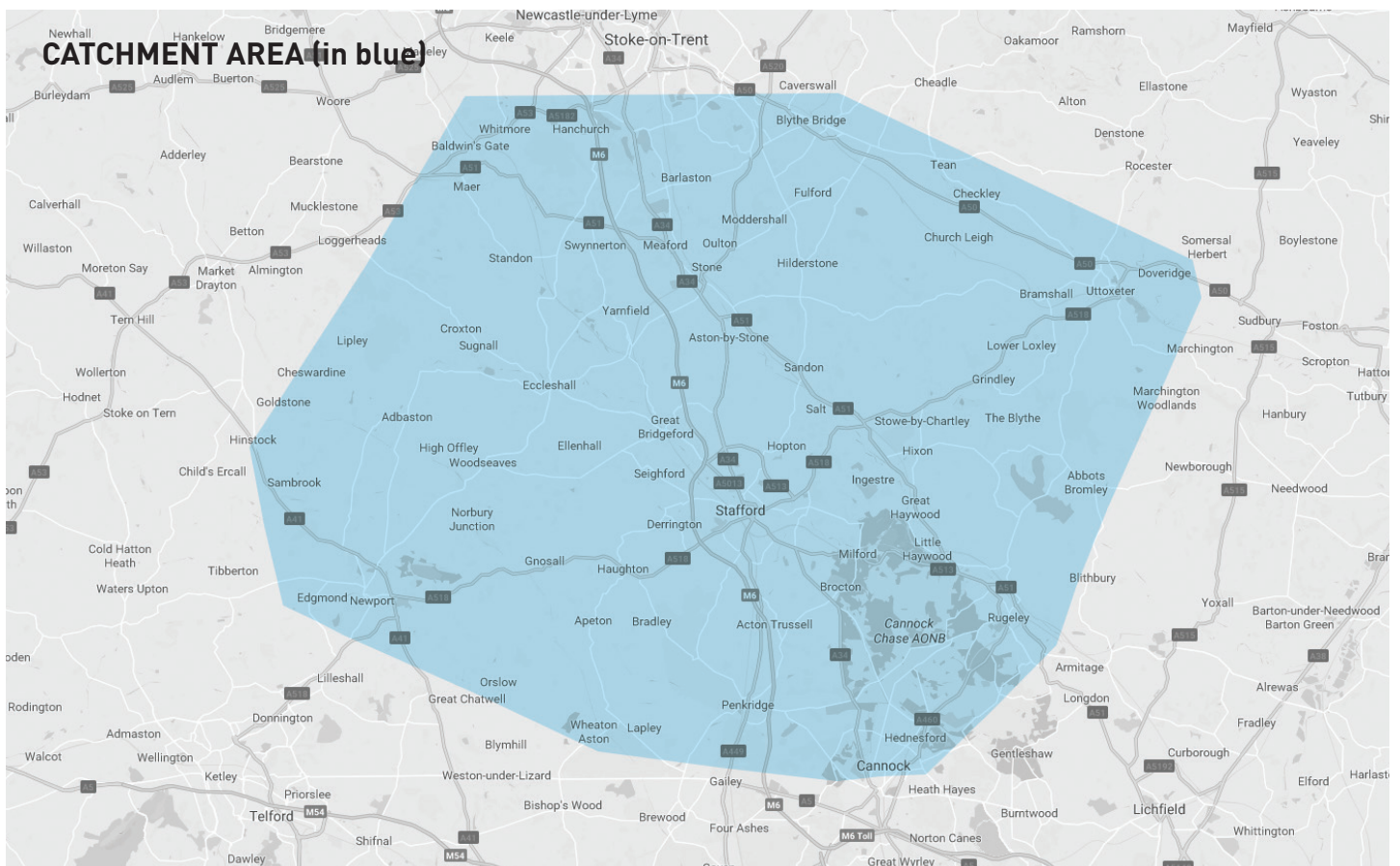
COMPETITION RULES

The competition is open to anyone aged eighteen years or over who is an individual registered as living in the Stafford Area or a business registered in the Stafford Area. Proof of address is required to validate the application. For the avoidance of doubt, for the purposes of this competition the Stafford Area is defined as the **catchment area** below.

There is no limit to the number of entries an individual can submit.

Any person connected with the competition including employees and immediate family of the Bear Companies and our years nominated charity staff are prohibited from entering.

By entering the competition the Applicants agree to be bound by these Terms and Conditions and that their full name/name of their business may be used by the competition for future promotional purposes.



APPLICATIONS OPENING DATE: 27th FEBRUARY 2019

Applications will be made available at the Launch Event at The Dog & Doublet Inn, Sandon, Stafford, ST18 0DJ from 4pm until 7pm on 27th February 2019.

All Bears will be present at the event and open to questions about the process. The Bears will not accept questions or requests for information from Applicants after this date.

24 hours after the Launch Event, applications will also be made available for download from the Bears' Lair Stafford website.

APPLICATIONS CLOSING DATE: 26th JUNE 2019

It is the Applicant's responsibility to ensure that postal entries are sent in good time and by 5pm on the Applications Closing Date, as any entry received outside of the stated times will not be considered in the interests of fairness to all Applicants.

APPLICATIONS SHORTLISTING EVENT: 24th JULY 2019

The Bears shall attend a closed short-listing event on the above date to agree the finalists.

The applications will be shortlisted on a blind basis in terms of the Applicant's personal details so as to avoid any potential conflict in terms of existing associations with of the Bear firms. All decisions will be based on the strength of the business idea submitted. The finalists' personal details will then be disclosed to the Bears and finalists will be notified within seven days of the Shortlisting Event either by phone or in writing.

Shortlisted Applicants will also be announced on The Bears' Lair website and social media. Attempts will be made to notify all unsuccessful applicants but depending upon the amount of entries received this may only be possible by social media.

The shortlisted Applicants must submit a presentation in advance and offer a live pitch to the Bears on the Grand Final Event night. Any resources in addition to the presentation must be submitted one week before.

Shortlisted applicants will be required to participate in associated marketing and social media activities during the process.

GRAND FINAL EVENT: 25th SEPTEMBER 2019

The Grand Final Event will be held at The Moat House Acton Trussell on the evening of Wednesday 25th September 2019.

Shortlisted Applicants must present their pre-submitted presentation pitch to the Bears on the Grand Final Event night.

The presentation will be immediately followed by questions from the Bears regarding their business proposal.

The Bears' decision as to the winner is final and will be announced at the end of the evening. The Bears' decision will be based upon which application is, in their view, the strongest proposal for a new business venture or expansion of a current business in the Stafford Area.
